Insufficient financial assistance

During this period, the government's support for public sculpture design in small and medium-sized cities is particularly important. Moreover, due to the use of low-cost and inferior materials, there are risks of damage and safety hazards in sculpture works. On the other hand, there is a big gap between Chinese designers and international designers. To further promote the public sculpture design of small and medium-sized cities in China, the quality of designers should be improved. However, due to the limitation of funds, designers rarely have the opportunity to study abroad, which makes the public sculpture design in small and medium-sized cities still have a certain gap compared with international sculpture.

Improvement Measures of Public Sculptures in Small and Medium-sized Cities in the New Era

Strengthen Urban Planning and Improve The Overall Layout

In the new era, the layout of public sculptures in small and medium-sized cities is often not well planned, which brings restrictions to urban development.
